### Status and Plans for Fermilab's Accelerator Complex and IOTA/FAST - Alexander Valishev

**Charge:** We ask the PAC to review the progress of the Fermilab accelerator complex toward delivering NuMI and BNB beams to the experiments in FY27 and FY28, as well as activities in preparation for the Long Shutdown. We also ask the PAC to review the status of Fermilab's IOTA/FAST facility and its alignment with the laboratory's scientific program.
